COMMITMENT

LEADERSHIP GRAND PRAIRIE is a learning experience and requires the following commitments by the participant:

- 1) Mandatory attendance at the orientation/retreat (September 10, 2008).
- 2) Attendance at monthly sessions (cannot miss more than two sessions).
- 3) Timeliness. This requirement is not only a demonstration of proper business etiquette; it will allow all participants to gain the most benefit from the program.
- 4) Active participation in a community service project to be completed by the class no later than May 2009.
- 5) Tuition for the program is \$600. \$150 deposit is required by August 15th. Payment in full is due by October 1, 2008.

Any program participant who is absent from the retreat or from more than two monthly meetings will not graduate with the class. Tuition refunds must be requested in writing by October 1, 2008. No tuition refunds will be considered after that date. A \$50 processing fee will be deducted from each tuition refund.
